

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to _____, and Nicole Griffin Wellness and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Nicole Griffin Wellness include _____. Collection of your Personal Information

Use of your Personal Information

Sharing Information with Third Parties

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Nicole Griffin Wellness. - SSL Protocol

 - Comply with the California Electronic Communications Privacy Act;
 - Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
